WHEREAS, on October 25, 1999, by Resolution No. R-292347, the City Council approved a loan of \$371,000 of CDBG funds to the Ocean Beach Community Development Corporation [OBCDC] to assist OBCDC in the purchase of property located at the northwest corner of Sunset Cliffs Blvd. and West Point Loma Blvd. in San Diego [the Property] for the proposed development of a community project known as the Ocean Beach Entry Way Project; and

WHEREAS, OBCDC has been unable to secure funding to complete the proposed Project . and desires to sell the Property to the City; and

WHEREAS, the City desires to acquire the Property in order to facilitate the future development of the Project; and

WHEREAS, the value of the Property, according to Real Estate Assets valuation staff is \$548,000; and

WHEREAS, the City will acquire the Property for a purchase price of \$531,000 in land and improvements, represented by the payment of \$160,000 to pay off the existing first trust deed on the Property and reconveyance of the City's second trust deed in the amount of \$371,000; and

WHEREAS, additional funds of \$88,000 are required to provide for (1) the acquisition of the furniture, fixtures and equipment the City is required to purchase from the tenant on the Property, (2) costs of demolition of the improvements located on the Property (3) costs of escrow, title, closing and administration; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$248,000 from CDBG Fund Nos. 18535 and 18537 for the fee acquisition of the 9,358 square-foot parcel located at 2304 Sunset Cliffs Boulevard in the City of San Diego, for the purchase of furniture, fixtures and equipment on the Premises, and for demolition, labor, title, escrow and miscellaneous costs associated with the acquisition.
