A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF MAY 15, 2002, FOR THE PROJECT AREA COMMITTEE FOR THE BARRIO LOGAN REDEVELOPMENT PROJECT AREA; AND AUTHORIZING THE EXTENSION OF THE PROJECT AREA COMMITTEE FOR ONE YEAR

WHEREAS, the Council by Resolution No. R-296209, amended the Procedure for the Formation of Project Area Committee for the Barrio Logan Redevelopment Project at its March 19, 2002, meeting; and

WHEREAS, after notice was given in accordance with the PAC bylaws, an election of the Project Area Committee [PAC] was conducted on May 15, 2002; and

WHEREAS, a representative from the City Clerk's Office attended the election on May 15, 2002, to ensure its validity; and

WHEREAS, pursuant to California Health and Safety Code section 33386, the
Redevelopment Agency of the City of San Diego, through its staff, shall consult with the PAC
for a three-year period after the adoption of the Redevelopment Plan, and for one-year extensions

thereafter by approval of the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the persons elected as members of the Project Area Committee for the Barrio Logan Redevelopment Project, as noted by the City Clerk's verification of the election results of May 15, 2002, attached as Exhibit A and incorporated by this reference, are approved as newly elected members to the PAC.

2. That the Council concurs that the election results of May 15, 2002, are valid and binding in accordance with the procedures adopted by Resolution No. R-296209.

3. That the Redevelopment Agency of the City of San Diego is directed to consult with and obtain the advice of the Barrio Logan Project Area Committee pursuant to the provisions of the California Redevelopment Community Law (Cal. Health & Safety Code § 33000 et seq.).

4. That the term of the Barrio Logan Project Area Committee is extended for one year.
