- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the portion of Road Survey 65 as more particularly shown on Exhibit "A" and on Drawing 19813-B, labeled Exhibit "B," on file in the Office of the City Clerk as Document

No. RR-296952, which said exhibits are attached hereto and made a part hereof, be, and the same is hereby ordered, vacated.

- 2. That this Resolution shall not become effective unless and until the the last final map within Vesting Tentative Map No. 04-0513 has been approved and recorded in accordance with the Subdivision Map Act.
- 3. That the City Engineer shall advise the City Clerk of the completion of the terms, conditions and the off-site street dedication of the said Vesting Tentative Map; and the City Clerk shall then cause a certified copy of this Resolution, Exhibit "A," and Exhibit "B" attested by him under seal, to be recorded in the Office of the County Recorder.
- 4. That in the event the last final map is not approved by August 6, 2005, this resolution shall become void and of no further force or effect.
