- 1. That the low base bid of Scheidel Contracting & Engineering, a California corporation, meeting the specifications for Sewer Group 672 in the City of San Diego, California, is hereby accepted, in the amount not to exceed \$1,443,712.80.
- 2. That the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. W.O. No. 174051. be and the same are hereby approved.
- 3. That the additional expenditure of an amount not to exceed \$620,823.92 from Sewer Fund 41506, CIP 44-001.0, Annual Allocation Sewer Main Replacement, is hereby authorized solely and exclusively for said project and related costs, provided that the City Auditor and Comptroller first furnishes a certificate certifying that the funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.

4. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budget funds, if any, to the appropriate reserves.
