
BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the plans and specifications for furnishing all labor, material, tools, equipment, transportation, and other expense necessary or incidental for General Requirements Contract 2002 B -- Building Modifications Contract, on file in the Office of the City Clerk on SEP 09 2002, ~~2002~~, and bearing official Document No. W.O. 461190, is hereby approved.
2. That the City Manager is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the above work, in accordance with the plans and specifications referred to above.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for as-needed construction services for a \$50,000 minimum, not to exceed the value of \$2,000,000 and a contract duration of two years, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for expenditure under the contracts are, or will be, on deposit in the City Treasury.
4. That the expenditure of an amount not to exceed \$2,000,000 from Fund Nos. 41506 and 41508, is hereby authorized, solely and exclusively to provide funds for the General Requirements Contract 2002 B-- Building Modifications, and related contingencies, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
