BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney is hereby authorized to apply for, accept and expend a \$71,274 Spousal Abuser Prosecution Program (SAPP) Grant from the State of California Department of Justice, under the terms and conditions outlined in the letter to Assistant City Attorney Gael Strack from Attorney General Bill Lockyer, attached hereto as Attachment A.

BE IT FURTHER RESOLVED, that the City of San Diego hereby agrees to hold the Department of Justice and the State of California harmless from any liability arising out of the performance of the grant agreement, including court actions or damages, agrees that the City will provide the necessary match of twenty percent (20%) and certifies that the City will not use the grant to supplant local expenditures.
