- 1. That the low base bid of BRH-Garver, Inc., a Texas corporation, meeting the specifications for East Linda Vista Trunk Sewer Phase II in the City of San Diego, California, is hereby accepted, in an amount not to exceed \$2,173,467.50.
- 2. That the City Manager is hereby authorized to award and execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 174191.
- 3. That the transfer of an amount not to exceed \$1,346,162 is authorized from Fund 41506, CIP No. 46-191.0, Brine Management Force Main and Pump Station to Fund 41506, CIP No. 46-162.0, East Linda Vista Trunk Sewer Phase II.
- 4. That Fiscal Year 2003 Phase I of the Project is hereby authorized in an amount not to exceed \$2,422,252.00.
- 5. That the additional expenditure of an amount not to exceed \$583,324.86 from Sewer Fund 41506, CIP No. 46-162.0, East Linda Vista Trunk Sewer Phase II, is hereby authorized

solely and exclusively for construction of the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that funds necessary for such expenditure under established contract funding phases are, or will be, on deposit with the City Treasurer.

6. That the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budget funds, if any, to the appropriate reserves.
