
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of the City, an agreement with Rick Engineering Company for Sewer and Water Infrastructure Design Services for the Engineering and Capital Projects Department [Agreement], in an amount not to exceed \$1,500,000, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No.

RR- 297128.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000 from Water Fund 41500, and an amount not to exceed \$1,300,000 from Sewer Fund 41506, is hereby authorized, solely and exclusively for the purpose of providing funds for the Agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to return any excess budgeted funds to the appropriate reserves.
