- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public service easement system for which the easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the water easement located in the remainder parcel of Parcel Map 17794, as more particularly described in the legal description, attached hereto as Exhibit "A", and as shown on Drawing No. 19306-B, attached hereto as Exhibit "B", is ordered vacated.

2. That the City Clerk shall then cause a certified copy of this resolution, with Exhibits "A" and "B", attested by him under seal, to be recorded in the Office of the County Recorder.


