A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF OCTOBER 1, 2002, FOR THE PROJECT AREA COMMITTEE FOR THE COLLEGE COMMUNITY REDEVELOPMENT PROJECT AREA AND AUTHORIZING THE EXTENSION OF THE PROJECT AREA COMMITTEE FOR ONE YEAR.

WHEREAS, the Council of the City of San Diego [Council] by Resolution No. R-280718, adopted the Procedure for the Formation of Project Area Committee for the College Community Redevelopment Project [Project] at its September 22, 1992, meeting; and

WHEREAS, after notice was given in accordance with the Project bylaws, an election of the Project Area Committee [PAC] was conducted on October 1, 2002; and

WHEREAS, a representative from the City Clerk's Office attended the election on October 1, 2002, to ensure its validity; and

WHEREAS, California Community Redevelopment Law requires that PAC's remain in existence for 3 years from the date of adoption of the redevelopment plan; and

WHEREAS, pursuant to California Health and Safety Code section 33386, the Redevelopment Agency of the City of San Diego [Agency], through its staff, shall consult with the PAC for a three-year period after the adoption of the redevelopment plan, and for one-year extensions thereafter by approval of the Council of the City of San Diego; and

WHEREAS, the elected members of the PAC have submitted to this Council information establishing the qualifications of each person relative to district, category or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the persons elected as members of the Project Area Committee for the College Community Redevelopment Project, as noted by the City Clerk's verification of the election results of October 1, 2002, attached as Exhibit A and incorporated by this reference, are approved as newly elected members to the PAC.

2. That the Council concurs that the election results of October 1, 2001, are valid and binding in accordance with the procedures adopted by Resolution No. R-280718.

3. That the Redevelopment Agency of the City of San Diego is directed to consult with and obtain the advice of the College Community Project Area Committee pursuant to the provisions of the California Redevelopment Community Law (Cal. Health & Safety Code § 33000 *et seq.*).

4. That the term of the Community College Project Area Committee is extended for one year.
