WHEREAS, the Council is asked to rename a small portion of Churchward Street to Brooks Huffman Plaza at the request of Council District Four to honor Brooks Huffman, a long time community leader; and

WHEREAS, the portion of Churchward Street that is being renamed is cut off from the remaining street to the east by a raised and fenced median strip in Euclid Avenue and this portion of Churchward Street is not a through public street because it is closed to the west by curb, gutter and sidewalk where Churchward Street intersects Imperial Avenue.

WHEREAS, this area now functions as a parking area for the surrounding businesses; and WHEREAS, the street name change is supported by the Encanto Neighborhoods Community Planning Group and all three businesses affected by the change; and

WHEREAS, Section 34091.1 of the California Government Code authorizes the City Council to change the name of City Streets by resolution; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council approves the street name change of a portion of Churchward Street to Brooks Huffman Plaza.

BE IT FURTHER RESOLVED, that the Council authorizes the expenditure of funds from Council District 4 discretionary funds for the amount of \$2,500.
