- 2. That the Council amends the Fiscal Year 2003 Budget for Fund No. 10227, Contributions to the Redevelopment Agency, in the amount of \$250,000.
- 3. That the Council authorizes the appropriation and expenditure of \$250,000 to be transferred from the City to the Redevelopment Agency as an interest-bearing loan to be used in the Barrio Logan Redevelopment Project Area.

4. That the Council directs the City Auditor and Comptroller to record the \$250,000 as an interest bearing loan from the City of San Diego to the Redevelopment Agency to be repaid as soon as practicable from tax increment or other appropriate revenues.
