



BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay the sum of \$89,915.13 in complete settlement of each and every claim against the City of San Diego, its agents and employees, resulting from a sewer main collapse on October 16, 2001, causing property damage to the home of Allison McBride. The City of San Diego previously paid a sum of \$42,509.93 from damages arising from this incident.
