- 1. That the Council authorizes amendment of the Fiscal Year 2003 Capital Improvements Budget by increasing CIP No. 29-410.0, Sandburg Neighborhood Park Tot Lot Improvements, in the amount of \$82,722 from Fund No. 79006, Mira Mesa Public Facilities Benefit Fund.
- 2. That the Council authorizes the City Auditor and Comptroller to appropriate and expend an amount not to exceed \$82,722 from CIP No. 29-410.0, Sandburg Neighborhood Park Tot Lot Improvements, from Fund No. 79006, Mira Mesa Public Facilities Benefit Fund, in the amount of \$82,722, for the purpose of park improvements.
