


RESOLUTION NUMBER R-297361

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$84,336 from CIP 35-089.0 Serra Mesa Branch Library, is hereby authorized, solely and exclusively for the purpose of providing funds for the Second Amendment to the agreement between Coombs and City for professional services required for schematic design of the Serra Mesa/Kearny Mesa Branch Library.
