That the City Manager is authorized to execute the GRC II contract with the lowest responsible and reliable bidder, which contract has been previously advertized (Bid No. K02235C, Volume 2), in an amount not to exceed \$4,000,000 contingent upon certification by the Auditor and Comptroller that the funds are available in CIP Fund No.21-834.0, and which contract has a duration not to exceed two years.
- 4. That the contract documents and technical specifications pertaining to GRC III for as needed construction, repairs and emergency work to non-Park and Recreation Facilities, filed

in the office of the City Clerk of the City of San Diego, California, on NUV 25 2002 and bearing official Document No. W.O. 218 445, are approved.

5. That the City Manager is authorized to execute the GRC III contract with the lowest responsible and reliable bidder, which contract has been previously advertized (Bid No.K02235C, Volume 1), in an amount not to exceed \$3,000,000 contingent upon certification by the Auditor and Comptroller that the funds are available in CIP Fund No. 21-834.0, and which contract has a duration not to exceed two years.

- 6. That the expenditure not to exceed \$7,250,000 from CIP Fund No. 21-834.0 is hereby authorized solely and exclusively for the purpose of providing funds for said projects and related costs, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are or will be on deposit with the City Treasurer.
- 7. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
