BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the City Manager is authorized to enter into or amend agreements in accordance with Council Policy 100-03, for and on behalf of the City with the San Diego Maritime Museum in the amount of \$25,000 for planning and design activities to locate the Museum within the North Embarcadero Plan project area, San Diego Navy Historical Association in the amount of \$35,000 for siting and design studies for a naval museum at NTC (aka Liberty Station), Old Town Chamber of Commerce in the amount of \$2,000 to provide lighting for the Old Town Entryway monument at Taylor & Juan Streets, North Bay Association in the amount of \$3,000 for the "Help Just One" event for disadvantaged children, and the Philippine Library & Museum in the amount of \$10,000 for equipment.
- 2. That the City Manager is authorized to incorporate into these agreements that there will be no on-going fiscal impact to the City for maintenance or improvements of the non-City facilities or programs.
- 3. That the City Auditor and Comptroller is authorized to reprogram an amount not to exceed \$89,000 in Council District 2 FY 1998, FY 2001, and FY 2003 CDBG Funds: \$25,510 from Fund 18533, \$12,745 from Fund 18536, \$242 from Fund 18537, and \$50,503 from Fund 18538 to CIP 29-532.0, Capehart Open Space Park Improvements.

- 4. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$80,000 from CIP 29-532.0 Capehart Open Space Park Improvements, Capital Outlay Sales Tax Fund 30245 to the General Fund to be used as follows: \$5,000 to Dept 120, City of San Diego Fire and Life Safety Services Department for the placement of a call box at Ladera Street; and \$75,000 to be re-allocated to the TOT Fund 10220 to be expended for agreements with the San Diego Maritime Museum, San Diego Navy Historical Association, Old Town Chamber of Commerce, North Bay Association, and the Philippine Library and Museum for the projects listed above.
- 5. Authorizing the Auditor and Comptroller to transfer \$9,000 from CIP 29-532.0-Capehart Open Space Park Improvements, Capital Outlay Fund 30245, to CIP 29-844, City of San Diego Park & Recreation Department for Point Loma Community Park Improvements.
