Diego, the easement with the right of ingress and egress for the construction and maintenance of

drainage facilities over, under, upon, and across Parcel 3, designated as "Drainage Easement

Granted Hereon," as granted and shown on the MAP and subject to the conditions set forth on

the MAP.

BE IT FURTHER RESOLVED, that this resolution will not be effective unless property

owner submits a tax certificate showing that there are no liens against the subdivision or any part

thereof for unpaid, state, county, municipal, or local taxes or special assessments collected as

taxes, to the satisfaction of the City Engineer.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and

directed to endorse upon the MAP, as and for the act of the Council, that said Council has

approved the MAP on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit

the MAP to the County Recorder of the County of San Diego, California for recordation.
