AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENTS TO THE CLASS I SOLID WASTE FRANCHISE AGREEMENTS WITH THE CLASS I FRANCHISEES AND TO EXECUTE NEW CLASS II SOLID WASTE FRANCHISE AGREEMENTS WITH THE CLASS II FRANCHISEES.

WHEREAS, continuing experience with the City's Non-Exclusive Solid Waste

Management Franchise System has revealed the need for changes to the franchise system and
to the franchise agreements as discussed in Manager's Report No. 03-067, on file in the office
of the City Clerk; and

WHEREAS, implementation of those changes requires amendments to certain sections of the San Diego Municipal Code governing the franchise system and modifications to the franchise agreements between the City and the Class I and Class II franchisees; and

WHEREAS, Class I franchise agreements are due for renewal and Class II franchise agreements otherwise need updating as discussed in Manager's Report Number 03-067, on file in the office of the City Clerk; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. The City Manager is hereby authorized and empowered to execute, for and on behalf of the City, first amendments to the Class I Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class I franchisees, listed in the attached Exhibit "A," under terms and conditions set forth in the First Amendment to Class I Non-Exclusive Franchise Agreement for Solid Waste Management Services, in the form of the First Amendment, on file in

The City Manager is further authorized and empowered to execute, for and on behalf of the City, new Class II Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class II franchisees and their affiliates, listed in the attached Exhibit "A," under terms and conditions set forth in the Class II Non-Exclusive Franchise Agreement for Solid Waste Management Services, in the form of the Agreement on file in the office of the City Clerk as Document No. OOcontingent upon the City Council's adoption of the companion ordinance amending Chapter 6, Article 6, Division 1, sections 66.0113, 66.0119, and 66.0123 of the San Diego Municipal Code.

Section 3. A full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
