AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING CHAPTER 13, ARTICLE 2, DIVISION 12, OF THE SAN DIEGO MUNICIPAL CODE, BY AMENDING SECTIONS 132.1202 AND 132.1205, PERTAINING TO THE MISSION TRAILS DESIGN DISTRICT OVERLAY ZONE.

WHEREAS, in August 1981, by Ordinance No. O-15566 N.S., the City Council adopted the Mission Trails Design District [Design District] to respond to the community's desire to have design guidelines that provide direction to projects that have a direct visual relationship to Mission Trails Regional Park; and

WHEREAS, the Design District affects areas within the East Elliott, Navajo and Tierrasanta communities as shown on the proposed Map No. C-916; and

WHEREAS, in April 1985, the City Council adopted the Mission Trails Regional Park Plan [Park Plan], by Resolution No. R-263065, with the expectation that the Design District would be amended in light of the Park Plan; and

WHEREAS, since construction of State Route 52, the Mission Trails Regional Park boundaries were changed resulting in the exclusion of portions of the East Elliott community from the Design District regulations; and

WHEREAS, this action seeks to continue application of the Design District regulations to all of the East Elliott community; and

WHEREAS, any properties exempt from the Design District regulations shall become

subject to the Design District regulations upon the rezone of the property to a use other than Residential-Estate, Single Unit, Small Lot or Townhouse; and

WHEREAS, based on the recommendations of the applicable officially recognized planning committees, the Mission Trails Citizen's Advisory Committee and the Mission Trails Regional Park Task Force, the Planning Commission initiated a rezone to amend the Design District regulations; and

WHEREAS, on July 24, 2003, the Planning Commission held a public hearing to consider all testimony and recommended to the City Council the adoption of the amendments to the Mission Trails Design District regulations; NOW, THEREFORE,

BE IT ORDAINED, by the City Council of the City of San Diego, as follows:

Section 1. That Chapter 13, Article 2, Division 12, of the San Diego Municipal Code is amended by amending Sections 132.1202 and 132.1205, to read as follows:

§132.1202 Where the Mission Trails Design District Applies

- (a) This overlay zone applies to those portions of the Navajo,

 Tierrasanta, and East Elliott communities that are within the
 boundaries shown on Map No. C-916, filed in the office of the City

 Clerk as Document No. OO-15566. These areas are shown
 generally on Diagram 132-12A.
- (b) Table 132-12A shows the supplemental regulations and the type of permit required by this division, if any, for specific types of *development* proposals in this overlay zone.

§132.1205 Supplemental Design Criteria

Except for property located within a RE, RS, RX, or RT Zone in the Navajo or Tierrasanta communities, as shown on Map No. C-916 and "development" that does not require a construction permit, all proposed development shall comply with the design criteria and standards of the Mission Trails Design Guidelines in the Land Development Manual.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. This ordinance shall take effect and be in force on the thirtieth day

from and after its passage.
