A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE ACQUISITION OF PROPERTY RIGHTS FOR THE TERRABROOK PARK SITE IN CARMEL VALLEY

WHEREAS, the City of San Diego and Westbrook Torrey Hills, L.P. [Developer] previously entered into the Torrey Hills Neighborhood Park Development Agreement dated January 8, 1998 [the Agreement]; and

WHEREAS, pursuant to paragraph 1.4 of the Agreement [Condition 1.4], Developer posted a performance bond in favor of the City in the amount of \$624,750 for the acquisition, design, and construction of 1.05 net usable acres of park to meet park requirements for Developer's project; and

WHEREAS, Condition 1.4 of the Agreement provides that the bond shall be released either upon payment to the City for acquisition and development of the park or upon design and construction of the park, and

WHEREAS, Developer is the fee title owner of 4.978 acres of land located on the Northwest corner of East Ocean Air Drive and Fairport Way in the community of Carmel Valley

and within the proposed 20-acre community park in Carmel Valley Neighborhood 8A (Project No. 21A-1 of the Carmel Valley Public Facilities Financing Plan); and

WHEREAS, Developer has agreed to transfer the 4.978 acre parcel to the City in exchange for release of Condition 1.4 and payment of \$278,000, representing the difference between the value of the 4.978 acre parcel plus frontage improvements, interest, and taxes (\$807,269) and the 1996 appraised value of the 1.05 acre parcel plus the costs of development (\$538,153), and an additional \$8,884 for the costs of sale; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council authorizes the City Auditor and Comptroller to appropriate and the City Manager to expend an amount not to exceed \$278,000 from C.I.P. No. 29-764.0, Carmel Valley Community Park—South Neighborhood Park (Fund No. 79008), for the acquisition of property rights from Westbrook Torrey Hills, L.P., and for labor, title, escrow and miscellaneous costs.
- 2. That the Council declares Condition 1.4 of the Torrey Hills Neighborhood Park

 Development Agreement dated January 8, 1998 (City Clerk Document No. C-08540) as satisfied

and authorizes the City Manager to release the performance bond posted by Westbrook Torrey Hills, L.P. in the amount of \$624,750.
