- (d) the public service easement for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of the sewer and water easement located within Lot 1 of Carmel Del Mar Neighborhood 5 East Unit No. 12, Map No. 12984, as more particularly shown on Drawing No. 00081-C, and described in the legal description marked as Exhibit "A," on file in the office of

the City Clerk as Document No. RR-297593, which is by this reference incorporated herein and made a part hereof, is ordered vacated.
