A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING A LOAN REPAYMENT OF \$337,997, APPROVING THE TRANSFER OF \$337,997 FROM THE CITY OF SAN DIEGO TO THE REDEVELOPMENT AGENCY AS AN INTEREST BEARING LOAN, AND REALLOCATING LOAN PROCEEDS PREVIOUSLY ALLOCATED TO VARIOUS PROJECT AREAS

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement redevelopment plans for the City of San Diego [City]; and

WHEREAS, the Southeastern Economic Development Corporation, Inc. [SEDC], has been authorized to administer certain redevelopment projects; and

WHEREAS, the Agency previously received Community Development Block Grant [CDBG] funds as a loan from the City and now proposes to repay a total of \$337,997 from the Mount Hope Redevelopment Project Area; and

WHEREAS, on June 18, 2002, the Agency, by Resolution No. R-03485, accepted a loan from the City of San Diego in the amount of \$2,221,459 to augment the Central Imperial Redevelopment Project Area in the amount of \$1,241,459, and to augment the Southcrest Redevelopment Project Area in the amount of \$980,000, which amounts the Agency now wishes to adjust; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City accepts a loan repayment from the Redevelopment Agency in the amount of \$337,997 from the Mount Hope Redevelopment Project Area.

That the City authorizes the transfer of \$337,997 from the City of San Diego as an

interest bearing loan to the Redevelopment Agency to be used in the proposed Fiscal Year 2003

project budget to augment the Central Imperial Redevelopment Project Area for project

implementation costs.

3. That the Fiscal Year 2003 SEDC Program Budget is hereby amended to reflect the

\$337,997 interest bearing loan to the Central Imperial Redevelopment Project Area to be used for

project implementation costs.

4. That the \$2,221,459 previously loaned to the Agency and allocated to the Central

Imperial and Southcrest Redevelopment Project Areas by Resolution No. R-296709 be

reallocated: \$1,371,459 to the Central Imperial Redevelopment Project, and \$850,000 to the

Southcrest Redevelopment Project Area.
