WHEREAS, on July 7, 2000, the City entered into an agreement with Estrada + EDAW Partnership for consultant services necessary for the design and construction of the North Chollas Community Park Phase 1A and 1B Improvements; and,

WHEREAS, Construction of Phase 1A Improvements has been completed; and,

WHEREAS, on July 10, 2001, the City entered into the First Amendment to Agreement with Estrada + EDAW Partnership to provide consultant services for the design of Phase 2 of North Chollas Community Park; and,

WHEREAS, during the permitting process for Phase 1B, additional studies and mitigation reports became necessary, and,

WHEREAS, the City Manager proposes entering into a Second Amendment to.

Agreement with Estrada + EDAW Partnership to provide consultant services necessary to conduct studies and prepare reports required by several regulatory agencies, including the Department of Fish and Game, the Army Corps of Engineers, and the California Regional Water Quality Control Board, to complete Phase 1B permit requirements.

NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego that the City Manager is authorized to execute, for and on behalf of the City, a Second Amendment to the Agreement with Estrada Land Planning + EDAW Partnership for professional services required to design and construct North Chollas Community Park Phase 1 Improvements; under the terms and conditions set forth in the Second Amendment to Agreement on file in the office of the City Clerk as Document No. RR-297605 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000 from CIP No. 29-667.0, North Chollas Community Park Phase 1 Improvements, State Park Bond Funds, Fund No. 38118, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
