respectively, on file in the office of the City Clerk as Document No. RR-297630, which is by this reference incorporated herein and made a part hereof, is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, along with the Revestment of Abutter's Right of Access, and the Relinquishment of Abutter's Right of Access to be recorded in the office of the County Recorder.
