WHEREAS, the Barrio Logan/Logan area of the City of San Diego would benefit from a study of transportation/land use planning issues, in part related to incompatibility of land uses and effects of diesel truck traffic near residential uses; and

WHEREAS, authorization is now being requested to submit a grant application, to the California Department of Transportation, accept and administer the grant funds and execute any necessary documents, as well as expend grant funds;

NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager or his representative is authorized to submit an application to the State of California Department of Transportation for a community-based transportation planning study in the Barrio Logan/Logan area.
- 2. That the City Manager or his representative is also authorized to take all necessary steps to secure the grant funds from the California Department of Transportation to provide funds for the above-mentioned study.
- 3. That the City Manager or his representative is authorized and empowered to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, payment request, which may be necessary for the completion of the aforementioned study.

- 4. That the City Manager or his representative is authorized, for and on behalf of the City, to accept, appropriate, expend, and administer the grant funds, if secured, in accordance with the terms and conditions set forth in the approved grant, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 5. That the expenditure of an amount not to exceed \$15,396 from Fund 100, Dept. 549, Org. 2150, Account 4222, Job Order No. 120131, as in-kind contributions for the grant from the Department of Transportation is hereby approved.
- 6. That the City Auditor and Comptroller is directed to establish a special interest bearing account for the grant, if secured.
