WHEREAS, the City of San Diego is requesting consideration of a \$5,000,000 grant from the State of California Wildlife Conservation Board to assist in the acquisition of property within the East Elliott area of the City of San Diego from willing sellers; and

WHEREAS, the City is proposing matching funds totaling \$1,000,000, from the Habitat Acquisition Fund (Fund No. 10571); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager or his representative is authorized to submit an application to the State of California Wildlife Conservation Board, for open space acquisition in the East Elliott area of the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager or his representative is authorized to take all necessary actions to secure funding.

BE IT FURTHER RESOLVED, that the City Manager or his representative, on behalf of the City of San Diego, is authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, amendments, and payment requests which may be necessary for the completion of the abovementioned project.

BE IT FURTHER RESOLVED, that the acceptance and expenditure of monies for the acquisition of real property rights, if grants are awarded, is authorized from CIP 37-443.0, MSCP, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the appropriation and expenditure of an amount not to exceed \$1,000,000 from the Habitat Acquisition Fund No. 10571 (\$900,000 from CIP 37-443.0, MSCP Acquisition and \$100,000 from Fund 10571/9544), as the local contribution for the acquisition of property rights in East Elliott, is authorized.
