WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public street easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of a portion of Alameda Place to facilitate development of the site; and

WHEREAS, in connection with the vacation, the City will reserve a drainage and sewer easement over a portion of the area that will be vacated; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the public street easement, either for the public street system for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes;
 - (b) the public will benefit from the vacation through improved utilization of land;
- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public street system or service easement system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the a portion of Alameda Place, reserving out a drainage and sewer easement, as more particularly described in the legal description, attached hereto as Exhibit "A" and as shown on Drawing No. 19884-B, attached hereto as Exhibit "B", is ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution with attached exhibits, attested by him under seal, to be recorded in the Office of the County Recorder.


