## RESOLUTION NUMBER R- 297781 ADOPTED ON MAR 25 2003

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of the storm drain easement within, to unencumber this property and facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the easement either for the facility or purpose for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated; and
- (b) the public will benefit from the vacation through improved utilization of land made available by the abandonment; and
- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public facility or purpose for which the easement was originally acquired will not be detrimentally affected by the abandonment, or the purpose for which the easement was acquired no longer exists; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the storm drain easement, as described in the legal description marked as

Exhibit "A-1," on file in the office of the City Clerk as Document No. RR-297781

which is by this reference incorporated herein and made a part hereof, is ordered vacated.

2. That this resolution shall not become effective unless and until the existing storm drain pipe has been relocated to the satisfaction of the City Engineer and a utility easement granted to the City of San Diego, therefore.

In the event the above conditions are not completed within five years following the adoption of this resolution, then this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned public improvements and the City Clerk shall then cause a certified copy of this resolution, attested by him under seal to be recorded with the office of the County Recorder.
