

RESOLUTION NUMBER R- 297791

ADOPTED ON MAR 25 2003

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO
EXTENDING THE EXISTENCE OF THE PROJECT AREA COMMITTEE
FOR THE CROSSROADS REDEVELOPMENT PROJECT.

WHEREAS, the Project Area Committee [the PAC] for the Crossroads Redevelopment Project [the Project] was initially formed by the election that was duly conducted on May 15, 2002, and a run-off election that was held on May 29, 2002; and

WHEREAS, Section 33386 of the California Community Redevelopment Law (Health and Safety Code Section 33000 *et seq.*) provides that the PAC shall remain in existence for a three-year period after the adoption of the Redevelopment Plan for the Project [the Redevelopment Plan], subject to one-year extensions by the Council of the City of San Diego [the Council]; and

WHEREAS, the Council and the Redevelopment Agency of the City of San Diego [the Agency] held a joint public hearing to consider adoption of the Redevelopment Plan on MAR 25 2003, 2003; and

WHEREAS, the Council has determined that the continuation of consultations between and Agency and the PAC, for a period of approximately three additional years beyond the initial three-year period after the adoption of the Redevelopment Plan, is important to the successful implementation thereof; and

WHEREAS, it is the intention of the Council, subject to requirements of, and to the extent allowed by law, to extend the existence of the PAC by consecutive annual extensions in

accordance with Section 33386 of the Community Redevelopment Law, for up to a maximum of three annual extensions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Council hereby extends the effective life of the Crossroads Project Area Committee for one additional year from its original expiration date of Aug 3, 2006 until Aug 3, 2009 and hereby indicates its intention, to the extent permitted by law, to extend the existence of the PAC thereafter by consecutive annual extensions in accordance with Section 33386 of the Community Redevelopment Law, for up to a maximum of two additional annual extensions.

2. That the Redevelopment Agency of the City of San Diego is hereby directed to continue to consult with and obtain the advice of the PAC concerning those policy matters that deal with the planning and provision of residential facilities or replacement housing and other matters that affect residents living within the Project for as long as the PAC continues in existence.
