BE IT RESOLVED, by the Council of the City of San Diego, that the low bidders meeting specifications of Clairemont Equipment Company, San Diego, CA (Items 1 and 2) and Hawthorne Machinery Company, San Diego, CA (Item 3), are hereby accepted and the awarded contracts for furnishing lease of various heavy duty equipment, as may be required for a period of one year beginning July 15, 2002, through July 14, 2003, for a total estimated cost of \$1,230,400 terms NET 30 days for both companies; with options to renew the contract for four additional one year periods; with price escalations for Hawthorne Machinery Company not to exceed 3.5 percent, and with price escalations for Clairemont Equipment Company not to exceed the manufacturer's price increase, of prices in effect at the end of each prior contract year, is hereby ratified.

BE IT FURTHER RESOLVED, that in the event either Contractor fails to perform in accordance with the contract specifications, the City Manager is authorized to award their items to the next low bidder meeting specifications.

BE IT FURTHER RESOLVED, that an additional expenditure of approximately \$288,000, from Fund No. 41200, Department No. 752, Organization No. 3101, Object Account No. 4685, and Job Order No. 002314 and 002315, is hereby authorized solely and exclusively for providing funds for said contract.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
