RESOLUTION ADOPTING A CONFLICT OF INTEREST CODE FOR THE NEW LOAN BOARD FOR THE SAN DIEGO REGIONAL REVOLVING LOAN FUND

WHEREAS, on July 8, 2002, the Council of the City of San Diego adopted resolution

No. 296757, establishing the San Diego Regional Revolving Loan Fund [SDRRLF] Board as part

of the City's plan to implement a grant awarded by the U.S. Department of Commerce,

Economic Development Administration [EDA]; and

WHEREAS, that resolution No. 296757 also authorized the City Manager to establish a Board to review SDRRLF loan applications; and

WHEREAS, the SDRRLF Board will consist of volunteer members from the private sector with expertise in commercial credit and lending, corporate finance, law, accounting, and emerging technologies; and

WHEREAS, California Government Code sections 87300 and 87302 require local agencies to adopt conflict of interest codes designating positions which involve the making or participation in making of decisions which may foreseeably have a material effect on financial interests, and for each position, the financial interests which are reportable; and

WHEREAS, the City Manager and City Attorney therefore recommend that a Conflict of Interest Code be adopted for the new Board for the SDRRLF because the Board for the SDRRLF will not be "solely advisory;" and

WHEREAS, the City Council concurs in this recommendation; NOW, THEREFORE,
BE IT RESOLVED, by the Council of the City of San Diego that a Conflict of Interest
Code for the Board for the new SDRRLF is hereby adopted, consisting of standard language
embodied in title 2, section 18730 of the California Code of Regulations, and any amendments to
that regulation duly adopted by the Fair Political Practices Commission, Appendix A showing
designated positions and their duties, and Appendix B showing the disclosure categories.

BE IT FURTHER RESOLVED, that a copy of the new SDRRLF Board's Conflict of Interest Code as adopted be placed on file with the Office of the City Clerk as Document No. RR-297849

BE IT FURTHER RESOLVED, that the persons whose positions are designated in the new SDRRLF Board's Conflict of Interest Code shall file their statements of economic interest with the City Clerk.

BE IT FURTHER RESOLVED, that the statements of economic interest filed by designated persons be retained by the Office of the City Clerk and be made available for public inspection and reproduction.

#### APPENDIX B

#### DISCLOSURE CATEGORY

All business positions, reportable investment and reportable income from persons or business entities that have applied, or in the foreseeable future may reasonably be expected to apply, for financing through the San Diego Regional Revolving Loan Fund.

#### Consultant\*

\*Consultant shall be included in the list of designated employees and shall disclose to the broadest disclosure category in the code subject to the following limitations:

The (executive director or executive officer) may determine in writing that a particular consultant, although a "designated position" is hired to perform a range of duties that are limited in scope and thus is not required to fully comply with the disclosure requirements described in this section. Such written determination shall include a description of consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The (executive director or executive officer's) determination is a public record and shall be retained for public inspection in the same manner and location as the conflict of interest code.
