  as interest bearing loans to provide funds for appropriate project expenses in the Fiscal Year

  2004 Redevelopment Agency Budget; and

3. That the City Auditor is directed to record the \$400,000 and \$130,000 as interest bearing loans to the Redevelopment Agency to be repaid as soon as practicable from tax increment or other appropriate revenues, from the respective project areas.
