BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the City Manager is authorized and empowered to execute, for and on behalf of the City, a First Amendment to Agreement with Powell/PBS&J, for water planning and water resource consulting services, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. 298116
- 2. That the Fiscal Year 2003 Capital Improvement Program [CIP] budget for Water Fund 41500, CIP 70.954.0, North City Reclamation System, is amended by increasing the budget amount by \$200,000.
- 3. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$200,000 from Water Fund 41500, Account 4222, Program 76880, Org. 880, to Water Fund 41500, CIP 70.954.0, North City Reclamation System.
- 4. That an additional expenditure of an amount not to exceed \$200,000 from Water Fund 41500, CIP 70.954.0, North City Reclamation System, and an additional expenditure of an amount not to exceed \$250,000 from Water Fund 41500, Program 768320, are authorized, solely and exclusively, for the purpose of providing funds for the above-mentioned First Amendment to Agreement, thereby increasing the compensation of the original Agreement to a total amount not to exceed \$700,000, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer

5. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
