

BE IT FURTHER RESOLVED, that Council Policy 900-07 regarding Business Improvement Districts is waived in order to allow for the City Manager to appoint an advisory board to oversee the City Heights Business Improvement District and the Mission Hills Business Improvement District.

BE IT FURTHER RESOLVED, that the City Manager is authorized to act as interim administrator for the City Heights Business Improvement District and the Mission Hills Business Improvement District in compliance with State law, and to create an administrative advisory board of not more than five business owners from within the City Heights Business Improvement District and the Mission Hills Business Improvement District for that purpose.

BE IT FURTHER RESOLVED, that the City Manager is directed to return to Council at the end of the strategic planning process with recommendations for the future management of the City Heights Business Improvement District and the Mission Hills Business Improvement District.
