WHEREAS, the affected property owner has requested the vacation of a portion of Goldfinch Street to facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the street, either for the public street system for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street or bikeway purposes;
  - (b) the public will benefit from the vacation through improved utilization of land;
- (c) the vacation does not adversely affect the General Plan or an approved Community Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the portion of Goldfinch Street, as more particularly described in the legal description, attached hereto as Exhibit "A" and as shown on Drawing No. 19878-B, attached

hereto as Exhibit "B", is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution with attached exhibits, attested by him under seal, to be recorded in the Office of the County Recorder.




