A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF MAY 21, 2003, FOR THE PROJECT AREA COMMITTEE FOR THE BARRIO LOGAN REDEVELOPMENT PROJECT AREA; AND AUTHORIZING THE EXTENSION OF THE PROJECT AREA COMMITTEE FOR ONE YEAR.

WHEREAS, the Council of the City of San Diego [Council] by Resolution No. R-274651, adopted the Procedure for the Formation of a Project Area Committee [PAC] for the Barrio Logan Redevelopment Project PAC at its October 30, 1989, meeting; and

WHEREAS, on December 12, 1989, the Council by Resolution No. R-274894 approved the PAC representatives initially elected to the PAC and has ratified each of the PAC elections annually through 2002; and

WHEREAS, the Barrio Logan Redevelopment Plan was adopted on May 20, 1991, by Ordinance No. O-17644 (NEW SERIES); and

WHEREAS, on March 19, 2002, Council by Resolution No. R-296209 amended the Procedures for the Formation of Project Area Committee for the Barrio Logan Redevelopment Project; and

WHEREAS, a after notice was given in accordance with the PAC bylaws, an election of the Project Area Committee [PAC] was conducted on May 21, 2003; and

WHEREAS, a representative from the City Clerk's Office attended the election on May 21, 2003, to ensure its validity; and

WHEREAS, pursuant to California Health and Safety Code section 33386, the Redevelopment Agency of the City of San Diego [Agency], through its staff, shall consult with the PAC for a three-year period after the adoption of the Redevelopment Plan, and for one-year extensions thereafter by approval of the Council of the City of San Diego; and

WHEREAS, the PAC continues to be a valuable community advisory board to the Agency; and


WHEREAS, the elected members of the PAC have submitted to Agency staff information establishing the qualifications of each person relative to district, category or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the council of The City of San Diego, as follows:

1. That the persons elected as members of the Project Area Committee for the Barrio Logan Redevelopment Project, as noted by the City Clerk's verification of the election results of May 21, 2003, attached as Exhibit "A," and incorporated by this reference, are approved as newly elected members to the PAC.
2. That the Council concurs that the election results of May 21, 2003, are valid and binding in accordance with the procedures adopted by Resolution No. R-296209.
3. That the Redevelopment Agency of the City of San Diego is directed to consult with and obtain the advice of the Barrio Logan Project Area Committee pursuant to the provisions of California Redevelopment Community Law (Cal. Health & Safety Code § 33000 *et seq.*).

4. That the term of the Barrio Logan Project Area Committee is extended for one year.
