## RESOLUTION NUMBER R- 298276 ADOPTED ON AUG 0 4 2003

WHEREAS, on August 3, 1998, the City Council authorized the City Manager to execute an agreement with the County of San Diego to provide animal control services for the period of July 1, 1998, through June 30, 2003 (Document No. RR-290573); and

WHEREAS, the County has successfully provided the City services for animal control, welfare, sheltering, licensing, and adoption during that time, and the agreement provides for an extension beyond June 30, 2003, by mutual consent; and

WHEREAS, the City desires to contract for animal control services with the County of San Diego for the period of Fiscal Years 2004 through 2008; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager is authorized to execute a contract extension and an amendment (an option to contribute to the Spay/Neuter Trust Fund in Fiscal Year 2003-2004) with the County for animal control services for the period of July 1, 2003 to June 30, 2008.

BE IT FURTHER RESOLVED, that the City Manager is authorized to expend \$4,756,911 from the General Fund Citywide Program - Animal Regulation Services for Fiscal Year 2003-2004, to be adjusted at year-end but not to exceed fixed gross cost of \$6,282,711 less actual revenues (estimated at \$1,525,800) in Fiscal Year 2004.

BE IT FURTHER RESOLVED, that Municipal Code section 44.0322, "Dog License Fees," is repealed and all animal services fee levels established by the County Board of Supervisors in County Code section 62.603 are adopted by reference in Section 44.0300, "San Diego County Animal Control Ordinance - Adoption by Reference."
