WHEREAS, APICAP's API Advocacy Program provides case management services that include assisting the clients in accessing and coordinating their benefits, from housing to Social

Security, medical/clinical referrals, and mental health referral and support services, along with paraprofessional support in the form of client home and/or hospital visits, and group social service, and recreational activities; and

WHEREAS, APICAP offers a wide range of prevention, risk reduction and health education services, all delivered by trained project staff and volunteers who adhere to stringent quality standards, including the cultural and linguistic appropriateness of all the HIV/AIDS information developed and distributed; and

WHEREAS, on September 20, 2003, APICAP will celebrate its 10th anniversary at a gala dinner at the Wyndham Emerald Plaza Hotel in downtown San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for an on behalf of the citizens of San Diego, does hereby recognize the 10th anniversary of the ASIAN PACIFIC ISLANDER COMMUNITY AIDS PROJECT (APICAP), and commends them for their outstanding health care advocacy, referral, and support services to those living with HIV/AIDS in the Asian Pacific Islander communities, and for their outreach to educate the community at large to issues unique to those in these communities living with HIV/AIDS.
