WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public street easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of a portion of A Street, Ash Street, 40th Street, 41st Street, and Alleys in Block 33, and the Alley in Block 35, all within Marilou Park, Map No. 517, to facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the public street system, for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes;
 - (b) the public will benefit from the vacation through improved utilization of land;
- (c) the vacation is not inconsistent with the General Plan or an approved Community

 Plan; and
- (d) the public street system or service easement system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the street vacation, as more particularly shown on Drawing No.00080-C and described in the legal description marked as Exhibit "A," on file in the office of the City Clerk as

Document No. RR-298419, which is by this reference incorporated herein and made a part hereof, is ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution with exhibits, attested by him under seal, to be recorded in the office of the County Recorder.




