A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE ACQUISITION OF PROPERTY RIGHTS FOR THE MISSION HILLS LIBRARY.

WHEREAS, the existing Mission Hills branch library is too small to adequately serve the Mission Hills, Old Town and Hillcrest communities; and

WHEREAS, a new 15,000 square foot facility is being designed that will provide a computer lab, community meeting space, special areas designed for children and teens, and expanded general seating and collection space; and

WHEREAS, the existing library site is too small to accommodate the new library, and the project requires a new, larger site; and

WHEREAS, a contingent offer for the required property rights has been made to the owner and accepted; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council authorizes the City Manager to expend an amount not to exceed \$2,200,000 from C.I.P. No. 35-096.0, for the acquisition of required property rights and related costs for a site located at 215 Washington Street for the new Mission Hills Library.
