A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY MANAGER TO EXECUTE TWO EASEMENTS DEEDS IN FAVOR OF SAN DIEGO GAS & ELECTRIC COMPANY.

That the City Manager, or his designee, is authorized to accept a Quitclaim Deed, executed by San Diego Gas & Electric Company, conveying back to the City the abandoned easement, which is as more particularly described in the deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 298465 ->

That the City Manager, or his designee, is authorized and empowered to execute, for and on behalf of the City of San Diego, a deed conveying to San Diego Gas & Electric Company, an easement for the purpose of constructing and installing underground facilities and appurtenances for the transmission and distribution of electricity and related purposes affecting that portion of Lot 1 of College Vista, according to Map thereof No. 3226, filed in the office of the County Recorder of San Diego County, as more particularly described in said easement deed on file in the office of the City Clerk as Document No. RR-
