A RESOLUTION APPROVING PLANS AND SPECIFICATIONS; AUTHORIZING ESTABLISHMENT OF PHASE FUNDING AND AWARD OF CONTRACT; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the plans and specifications for the Pipeline Rehabilitation in Right-of-Ways and Easements Phase C Project [Project], filed in the office of the City Clerk as Document No. W.O. 179291, are approved.
 - 2. That, after advertising for bids in accordance with law, the City Manager is authorized to establish contract funding phases, to award a contract to, and to execute a contract with, the lowest responsible and reliable bidder for the Project in an amount not to exceed \$9,949,121, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit with the City Treasurer.
 - 3. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$989,526 from Sewer Fund No. 41506, CIP 46-191.0, Brine Management Force Main and Pump Station and \$730,064 from Sewer Fund No. 41506, CIP 46-195.8, Miramar Road Trunk Sewer, for a total not to exceed \$1,719,590, to Sewer Fund No. 41506, CIP 46-506.0, Pipeline Rehabilitation in the ROW and Easements.
 - 4. That the expenditure of an amount not to exceed \$9,949,121 of which an amount not to exceed \$9,499,163 is from Sewer Fund No. 41506, CIP 46-506.0, Pipeline Rehabilitation in

the ROW and Easements and an amount not to exceed \$449,958 is from Sewer Fund No. 41506, CIP 46-193.0, Annual Allocation - CIP Contingencies, is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit with the City Treasurer.

5. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
