A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO
RATIFYING THE CITY HEIGHTS REDEVELOPMENT PROJECT
AREA COMMITTEE ELECTION RESULTS IN 2004.

WHEREAS, on September 14, 1999, the Council of the City of San Diego [Council] by Resolution No. R-292185 (amended July 9, 2001), adopted the Procedure of the Formation of a Project Area [PAC] for the City Heights Redevelopment Project [Project]; and

WHEREAS, on July 15, 2003, the Council by Resolution No. R-298199 amended the Procedure for Formation on a PAC for the City Heights Redevelopment Area; and

WHEREAS, California Community Redevelopment Law [Law] requires that PACs remain in existence for three years from the date of adoption of the redevelopment plan; and

WHEREAS, on August 4, 2003, the Council by Resolution No. R-298305 authorized a one-year extension of the PAC and directed Redevelopment Agency staff to notice and conduct an election for the City Heights Redevelopment Area PAC in 2003; and

WHEREAS, the annual election was conducted on November 4, 2003, after notice and according to the Project PAC bylaws and procedures enumerated within the documents approved by the Council; and

WHEREAS, a representative from the City Clerk's office attended the November 4, 2003, election to ensure its validity; and

WHEREAS, the elected members of the PAC have submitted to this City Council information establishing the qualifications of each person relative to district, category or organization as appropriate; NOW THEREFORE.


BE IT RESOLVED, the City Council of the City of San Diego as follows:
