WHEREAS, the City of San Diego is a member of the San Diego Model School Development Agency [SDMSDA]; and

WHEREAS, the City's share of the SDMSDA's Fiscal Year 2004 Budget is \$25,194; and WHEREAS, SDMSDA has entered into a contract for program management services with Sedona Pacific/Lankford & Associates Inc., and the City's share of the contract costs for Fiscal Year 2004 will be an amount not to exceed \$46,285; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council authorizes the City Manager or designee to accept a loan repayment from the Redevelopment Agency of the City of San Diego of up to \$71,479 from the City Heights Redevelopment Project Area (Fund No. 98211) to the City Community Development Block Grant [CDBG] Program (Fund No. 18502).
- 2. That the City Manager is authorized to amend the Fiscal Year 2004 CDBG

  Program Budget to include the loan repayment and authorize allocation of an amount not to

  exceed \$71,479 from the City's CDBG Program (Fund No. 18502) to fund the City's share of

  Fiscal Year 2004 San Diego Model School Development Agency [SDMSDA] costs and program

  management services.
- 3. That the Council authorizes the City Manager to transfer \$71,479 from CDBG Program Income Fund No. 18502, to CDBG Fiscal Year 2004 Fund No. 18539 and to

appropriate and expend and amount not to exceed \$71,479 for the City's share of Fiscal Year 2004 SDMSDA costs and program management services.

4. That the Council directs the City Manager to periodically provide informational reports regarding the proposed activities, including potential costs, of the SDMSDA.
