BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager is hereby authorized and empowered to negotiate and award a task order under the existing agreement for as-needed engineering services with Brown and Caldwell, on file in the office of the City Clerk as Document No. RR-296103 dated February 25, 2002, for pilot testing of Biological Aerated Filter Technology at the Point Loma Wastewater Treatment Plant.


BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,700,000 from Fund 41509, is hereby authorized solely and exclusively for the purpose of funding the above referenced task order with Brown and Caldwell, in the following manner:

- \$707,000 for FY2004
- \$993,000 for FY2005, contingent upon City Council approval of the Metropolitan Wastewater Department's operating budget and the City Auditor and Comptroller first furnishing one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
