WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public service easements by City Council resolution where the easement is no longer required; and

WHEREAS, the affected property owner has requested the vacation of a general utility easement within a previously vacated portion of Bancroft Street; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the general utility easement either for which it was originally acquired, or for any other public use of a like nature that can be anticipated; and
  - (b) the public will benefit from the vacation through improved utilization of land; and
  - (c) the vacation is consistent with the General Plan or an approved Community Plan; and
- (d) the public service easement system for which the easement was originally acquired will not be detrimentally affected by this vacation, NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the general utility easement within a previously vacated portion of Bancroft Street, as more particularly described in the legal description, marked as Exhibit "A," and as shown on Drawing No. 20167-B, marked as Exhibit "B," on file in the office of the City Clerk as Document No. RR-298741, which is by this reference incorporated herein and made a part hereof, are ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with exhibits, attested by him under seal, to be recorded in the office of the County Recorder.


