AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING CHAPTER 5, ARTICLE 6, DIVISION 0, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 56.54 RELATING TO ALCOHOLIC BEVERAGE CONSUMPTION PROHIBITED IN CERTAIN AREAS.

BE IT ORDAENED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 5, Article 6, Division 0, of the San Diego Municipal Code is amended by amending section 56.54, Appendix 56.54A, and Appendix 56.54C to read as follows:

§56.54 Alcoholic Beverage Consumption Prohibited in Certain Areas

(a) Definitions. For purposes of sections 56.54, 56.55, and 56.56, the following terms are defined as follows:

"Alcoholic beverage" and "Beach" [No change.]

"Public park" means any property designated, dedicated or developed by or on behalf of the City of San Diego for park or open space use.
