- 2. That the City Auditor and Comptroller is authorized to increase the Fiscal Year 2004 Capital Improvements Program Budget by \$9,820.36 in CIP 290-657.0, La Mirada Elementary School Joint Use Improvements, Fund No. 10365, Public/Private Partnership for the Project.

3. That the City Auditor and Comptroller is authorized to appropriate and expend \$182,820.36 from CIP 29-657.0, La Mirada Elementary School – Joint Use Improvements, in Fund No. 10365, Public/Private Partnership, for the Project.
