That the City Auditor and Comptroller is authorized to appropriate and expend an amount of \$250,000, Fund No. 702591, Talmadge MAD Capital Improvements Fund, from CIP No. 39-010.0, Talmadge Streetscape and Lighting Improvements, for the design and construction of street lights and streetscape improvements, contingent upon the City Auditor certifying that funds are available.

6. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
